1. Audits –21/22 complete – Table to next meeting per Manager Orion
2. Finances – Monthly Payment Report – **Making some changes and cuts in different areas along with a 2026 payment schedule.**
3. FEMA Project – Bid from WZI to perform A&E, project has moved from FEMA to CALOES for completion. **Meeting last Friday. FEMA will close out and Orion to meet this Friday with a push to get these projects completed.**
4. Cemsites Software – Data clean-up. The data itself will be a long-term, time-consuming project. Cemsites is well on its way.
5. Groundskeeping – Current Well investigation, Water surveyor, Solar performance report, Headstone cleaning and leveling Kern Well – Paiute Pump, per approval came last month and pulled out all the pipe and pump. They are waiting for dirt to settle so they can drop a camera down and look. On-going investigation.  
Water finding company identified a new location. If we move forward, a location to drill has been found on south end near the laydown yard, which is different from the last time. The old location was near to the old well. New location identified. Orion hopes funding will come in so we can move forward. Solar is project is phenomenal. Little projects being completed
6. Volunteer Projects – None currently - Drip system was buried
7. Improvements – None currently – Holding off until approved funding and focused on completing tasks that can be done without water.
8. Marketing – Brochure Distribution – Ordered more brochure holders that she can take out to sites.
9. Events – Veterans Day – Honoring Frank and dignitaries will be present to celebrate our 99-year-old WWII Veteran.
10. Training – On-Line Ethics Seminar Nov 12, Anti-Harassment Training Dec 10. Self-paced class available for those that are working tomorrow.
